Now, therefore, in exercise of the powers conferred by clause (b) of sub-section (5) of section 8 of the Central Sales Tax Act, 1956 (Central Act, No.74 of 1956), the Governor of Himachal Pradesh is pleased to direct that tax payable under sub-section (2) of section 8 of the aforesaid Act on the sale of goods made in the course of inter-Stat trade or commerce by the industrial units manufacturing Information Technology and Bio-Technology goods to the non-dealers like Banks, Educational and Medical institutions, Autonomous bodies etc. shall be calculated @ 1% subject to furnishing of following declaration in Form 'CC' by the purchaser, with immediate effect in the public interest.
